**REQUEST FOR DAILY HUNTING/FISHING PERMIT (MLAAPR 420-2)**

**(Section A – Privacy Information)**

1. Authority: Title 10, US Code Section 3012.
2. Principal Purposes: Badge number and Permit number which is personal information and needed to determine eligibility to hunt/fish will aid Guard Department in identifying person(s) authorized entry into a particular area and strengthen entry control procedures for security areas.
3. Routine Uses: Personal information is not used for any other purpose.
4. Disclosure is voluntary. Failure to complete form in its entirety would delay assignment of local zone to hunt and fish on the installation. Failure to report hunting/fishing statistics could result in denial of hunting/fishing privileges.
